




## What is a Biopharmaceutical?



 An individual, group or organisation who may affect, be affected by, or perceive itself to be affected by a decision, activity or outcome of a project









**Core Members: SET** 



**Standing Members:** 

R&D Heads, Regional Commercial EVPs



**TA / Business Heads:** 

R&D, Commercial, Regulatory, Biometrics, Clinical, etc.



**Agenda-driven Members:** 

Franchise Heads, Biomarkers, Legal, BD, etc.



- Simple & clear
- Tell the story
- Less is more
- Answer questions succinctly
- Prepare & practice
- Be confident!



## What do people want out of governance?



#### **Committee Members**

- Information that enables effective decision making
  - Executive-level of detail
  - Focus on key messages & critical issues
  - Simple, understandable slides
- Coherent strategy & supporting story
  - Reasons to Believe
  - Value Proposition
  - Comprehensive (use the templates!)
- Well-planned for executional success
- Reasonable slide count



**Presenters** 

- Clear decisions & guidance
- Alignment of advice
- Speed & flexibility
- Minimal burden; stay on critical path
- Positive experience with leaders



## Tips for presentations

#### **Preparing the pre-read (presentation) deck**

#### Single deck submission

- Indicate pre-read slides
- Plan early! Pre-reads due ~at least one week prior
- Minimal to no changes (unless LT approved)

#### Include:

- Team slide
- Decisions needed (front & back of presentation)
- Clear Executive Summary
- Indicate pre-read slides
- Slide numbers

#### Use templates & guidance

Communicate closely with Secretariat

#### During the presentation...

- Focus on key messages
- Be ready for discussion throughout
- Listen carefully to questions... and answer <u>them</u> concisely
- Allow 10-15 minutes at end for discussion & decisions

#### Bring the right people

- Team attendance ≤3 people
- Must have clear role & purpose
- Know who is expected to answer majority of questions
- Know who is "leading" the presentation

Listens to ensure delivery models meets customer needs




